Decision: Approval to hire a consultant to take on work around the Goal 16 Toolkit workshops.

Discussion: Four out of five Steering Committee members agreed that this consultancy should:

1. Be flexible in working location, with a preference for the consultant to be located in the global south
2. Focus exclusively on further workshops and follow-up on the Goal 16 Advocacy Toolkit
3. Engage regional groups extensively in work around workshops
4. Report to and be supervised by the TAP Secretariat directly

Reservation: While supportive of the overall intent of hiring a capacity building expert to support TAP's work immediately, WFUNA expressed a reservation on the decision taken and the above terms outlined for the consultant, and requested the Steering Committee to

respect the agreement of the current grant – in particular WFUNA’s role of responsibility for supervising the position and that it be based in New York.
