## c. Future fundraising plans

#### Discussion:

The Secretariat reminded the Steering Committee that the new strategic planning process will begin at the start of next year, 2022. In soliciting feedback from the Steering Committee on the latest draft proposal, it was suggested that the vision and the theory of change be more succinct.

The Secretariat proceeded to update members on Mott Foundation funding beyond 2021. Unfortunately, it may decrease from the current 400,000/year to 300,000 or 200,000 over the next three years. This is because Mott has expressed concern that TAP hasn't placed a specific focus on access to justice (16.3) explicitly. The Secretariat suggested that we add access to justice related activities to the 2021 WorkPlan-- possibly updating the Justice Advocacy Toolkit, which was drafted by TAP Partners dedicated to 16.3. This could be a simple project added to the core work to incentivize Mott to keep funding at the current rate-- as it would not require much effort from the secretariat itself.

However, some members worried that adding more to the WorkPlan, especially around new product development, can take away focus on the current priorities that were decided upon. As long as the cut in funding doesn't put the Swiss funding at risk (which cannot be a certain percentage of the total funding) then the Secretariat should focus on the workstreams already prioritized. The Secretariat confirmed that a decrease in Mott funding wouldn't put the Swiss funding for 2021 at risk, but there would need to be a push for new funding sources for 2022 and 2023. Nonetheless, there is enough time between now and the next year to find fundraising of 50,000 to 100,000.

On the topic of fundraising, the secretariat suggested that the Steering Committee turn attention to funding and dedicate a meeting on discussing possible fundraising strategy in the next few weeks.

#### **Decisions:**

The Steering Committee decided to keep the current working plan for 2021 as is without adding access to justice programs, even if this results in a decrease in funding from Mott.

### Follow up:

- Securing another source of funding will be necessary ahead of 2022. The Steering Committee should plan on a dedicated discussion on fundraising strategy in the coming weeks.
