# 1. Review and Approval of last Steering Committee Call Notes <u>Discussion:</u>

2. Update and Next Steps on TAP Steering Committee Nomination and Elections

## **Discussion:**

The Coordinator provided the Steering Committee the following updates on nominations so far (open for a little over two weeks so far) which can be accessed from the link below:

The coordinator noted that in previous election cycles, many partners wait until a few days before the deadline to submit their application. 3 out of the 5 applications so far are eligible all from the global south (the others are not partners). We need to focus on getting more nominations in quantity and quality. The deadline for nominations is a week from today on November 23rd. As discussed in the previous SC calls, the timeline, next steps and deadlines were decided as follows:

- Final Reminders of TAP Partner Applications before deadline: Tuesday, 8 November

- Application Deadline for Nominations: Tuesday, 23 November 2021
- Final review of nominations by Steering Committee: Wednesday, 24 November 2021
- Voting: Wednesday 24 November Friday 10 December

## The potential options for outreach are as follows:

- Additional outreach and encouragement from the SC (reachout bilaterally skipping the secretariat)
- Change the ToR to allow the secretariat to perform outreach
- Extending the deadline another the week

SC members agreed to change the terms of reference to allow the Secretariat to engage in outreach. CSPPS suggested that the secretariat draft an email on behalf of the SC to encourage partners to nominate themselves and the importance of the SC as a participatory decision-making opportunity.

Another question on the voting process regarding the gender equality requirement in which at least one organization is led by a female representative. Accountability Lab as a carry over organization fits this requirement, should we keep it as a requirement regardless? The SC agreed to keep this as a requirement.

- Change the ToR to allow the Secretariat to engage in outreach and encourage partners to nominate themselves
- The Secretariat will draft an email on behalf of the SC co-chairs encouraging partners
- The Secretariat will provide periodic updates to the SC over the next week on nominations, after which the deadline can be extended as needed

The Secretariat recommends that the Steering Committee move to approve Jendela Desa Indonesia as a Partner. While Liberia's Corrupt Politicians has a satisfactory application, it was met with mixed feedback from partners. Therefore, the coordinator recommends the other three for reapplications.

There was concern that the recommended application did not have a strong enough link to SDG16+ However, partner applications can be related to SDG16+ and/or SDG Accountability. CSPPS clarified that those that have work related to either SDG16+ OR SDG Accountability should be able to make a stronger case linking their activities to TAP's mission and the application should better reflect those links.

### **Next Steps:**

- The SC agreed to request a reapplication to all four of the applicant organizations
   Indonesia Jendela would need a more concrete and specific commitment
- Secretariat will edit the Partner application so that applicants can clarify their links to specific SDG 16 targets and thematic areas around SDG Accountability

There was some clarification on the funding guidelines proposed deadlines and window for review. Now, the next questions are when TAP releases these guidelines and call for proposals and how it is promoted. Either the application can be released before the holidays or after the holiday season in the first quarter of 2022, either way for at least a few months. This would allow the new SC to take ownership of the initiative.
